



# **Terms of Service**

If you are not satisfied with an item purchased from us online, we will happily accept return items for a full refund within 14 days of delivery.

Excisions may apply for special order items such as upholstery items ie. sofas or any items that have been made to your specific choices and therefore made to order.

### How to Return or Exchange a Product

Please contact our Customer Support team on 0191 2327929 or email so that we can arrange for your item[s] to be collected on a mutually agreed date. Collections are free-of-charge.

Exchanges and refunds will be issued once the item[s] has reached us, provided that the item[s] has been returned in the condition in which it was delivered.

All refunds will be made via the original payment method, and will appear in your account within 5 to 7 working days as Albany Office Equipment Wholesale Ltd. Please be aware that if you made your purchase using a method other than credit card, you may be prompted to provide bank details so that we can credit your account.

Please keep in mind that furniture is vulnerable to damage during delivery; please be sure to keep the original packaging materials for items you may wish to return.
